Do Your Elected Representatives Vote to Protect Seniors?

We have you received the call that your car warranty is expiring? Or the one I often get from Amazon, saying my card has been charged \$1,999 for an iPhone 11? Maybe you got the one that your grandson is in jail and needs bail. These are all scams and robocalls.

Many come from small Oregon cities like Susanville and Stayton. Some calls show up under the name of one of your contacts, so you answer it. This is called spoofing. How do they do this and why isn't it illegal?

Between June 2020 and June 2021, 59 million people lost a combined \$29.8 billion according to Truecaller, a phone number identification app. We have all heard of someone who has fallen for one of these scams. It can be easy to be tricked, especially if you are not on top of your finances — when I got the call about a charge on my Amazon card, I knew it was a hoax because I don't have an Amazon card. But a spouse who does not take care of the bills may be unaware of that and fall victim.

The Federal Communications Commission (FCC) recently implemented industry rules called "STIR/SHAKEN" to help mitigate spammers' efforts. Phone providers are now required to authenticate that the call people received really is from the number shown on the caller ID. The STIR/

SHAKEN anti-spoofing rules went into effect on June 30, 2021. Large service providers like Verizon, AT&T or T-Mobile are now required to implement caller ID authentication standards and to submit a plan outlining their robocall mitigation efforts. Some of the smaller providers (those with 100,000 customers or fewer) have an extension on those dates.

Robocalls are on the decline, although it may not seem like it. August saw 4.1 billion robocalls, down 4.4 percent from July, which was down 4.8 percent from June, according to YouMail, a robocall blocking software company. Efforts by Verizon to

CEOs Against Medical Price Negotiation Were Paid \$400 Million Collectively Last Year

he fight over allowing Medicare to negotiate lower drug prices, and use the savings to expand guaranteed dental, hearing and vision benefits, continued in earnest on Capitol Hill this month.

Executives from 33 pharmaceutical corporations sent a letter to Congress reiterating their opposition to allowing Medicare to negotiate lower prescription drug prices. The letter contained numerous falsehoods about the impact of Medicare drug price negotiations and asked Congress to block any legislation that would weaken their monopoly power to set prices. In response, Patients for Affordable Drugs Now, a bipartisan organization fighting for lower drug prices, released new data showing that Big Pharma CEOs were collectively paid \$400 million in 2020. The average compensation for CEOs was \$12.5 million, 185 times the average American household income — and 420 times the income of Medicare beneficiaries.

The report also shows that 19

of the 33 countries that wrote to Congress are based in foreign countries, where they charge less than half what they charge Americans for the same drugs.

"Americans pay the highest prices in the world for prescription drugs and those CEOs are fighting tooth and nail to keep it that way," said Richard Fiesta, Executive Director of the Alliance. "We are doing everything we can to defeat these corporations and get this common sense solution into law. President Biden made this a priority, and Congress needs to deliver this for the American people."

Extreme Wealth Inequality at All Ages is Tied to Retirement Struggles for Many Americans

esearchers with the National Institute on Retirement Security have found wealth inequality among members of the Baby Boom generation, which they defined as Americans aged 55-73.

The entire bottom half of Baby Boomers held only two percent of their generations wealth in 2019, threatening the retirement security of millions of Americans who are at or close to retirement age. Comparable levels of inequality were found among younger demographics, including "Gen X," aged 39-54, and Millenials, aged 23-38. When broken down by racial and ethnic groups, white Baby Boomers held 91 percent of the financial assets for their age group, while Black and Hispanic Baby Boomers own only a sliver of the total.

Financial asset ownership, including 401(k) plans, individual retirement accounts and other forms of investment, is especially important to retirement security because so many workers are expected to generate their own personal retirement savings as pensions become less common.

"Wealth inequality hurts Americans of all ages, and is particularly dangerous for older people," said Joseph Peters, Jr., Secretary-Treasurer of the Alliance. "We need to expand Social Security and increase benefits, since it is clear that more and more Americans will need to rely on it for the majority of their retirement income."



ROSE Recipe: Carrot Cake

This recipe comes from a family friend of my wife, Genny. Joe was her dad's best friend and the two families spent many occasions together. Joe would make and bring this cake to all the family events. I hope you enjoy it as much as our family has.

Joe Driscol's Carrot Cake

2 tsp baking soda
1 1/2 tsp salt
2 cups flour
2 tbsp baking powder
1 1/2 tsp cinnamon
2 cups sugar
1 1/4 cups salad oil
4 eggs
2 cups finely grated carrots
8 oz. can crushed pineapple
1/2 cup chopped nuts
3 1/2 oz. flaked coconut

Cream Cheese Frosting 1/2 cup butter 8 oz. cream cheese



1 tsp vanilla 1/2 box powdered sugar

Sift together flour, baking powder, baking soda, salt and cinnamon. Add sugar, salad oil and eggs; mix well. Add carrots, pineapple, coconut and nuts. Blend and pour into a lightly greased and floured cake pan. Bake at 350 degrees for 45-50 minutes.

To make the frosting, combine butter, cream cheese, vanilla and powdered sugar. Spread onto cake.

lessen robocalls led to 500,000 fewer each month. AT&T says they can identify and label 1 billion robocalls each month while T-Mobile says they can verify 300 million of their calls each day.

While STIR/SHAKEN helps crack down on domestic calls, little can be done with those coming from outside the US. The FCC has little authority abroad. So, will many of these scammers move their operations overseas? Probably!

What can you do for now? Many call providers have their own robocall blocking apps. On my iPhone, I can block all calls that are not originated from someone in my contact list. (To do this, go to settings, phone, silence unknown callers.) When a call from an unknown number comes in, my phone doesn't even ring. If it is not a spammer, the caller can leave a message for me to return their call. I set this up six months ago and I have only received one call from someone I needed to call back.

Check out your phone for options available to you. Stay safe and stay aware of these scammers. Scammers will always find new ways to steal and cheat — don't let them!
