Prescription Savings for Medicare

President Biden signed into law the Inflation Reduction Act. This bill will help lower the cost of prescription drugs for many Medicare benificiaries. Studies have shown one in four people over age 65 do not take at least one medication as prescribed

due to its cost. The Inflation Reduction Act will help those struggling to afford their prescriptions as needed. Here are some of the things which are included:

Premiums for Medicare Part D (prescriptions) insurance will not increase more than six percent a year through at least 2029.

Starting in January 2023, those covered by Medicare will spend no more than \$35 out-of-pocket per month for insulin. In 2026 and beyond, insulin will be priced at \$35 per month or 25 percent of the negotiated price, whichever is lower.

Also in January, all recommended adult vaccines will be free for those on Medicare. These vaccines that are recommended by the Advisory Committee on Immunization Practices

(shingles, flu, tdap and more) will be available to you at no out-of-pocket cost.

Also beginning in 2023, the Department of Health and Human Services (HHS) must negotiate prices of 10 Medicare Part D drugs, rising to 15 in 2027. In 2028, HHS will negotiate prices of 15 high-priced drugs

in Medicare Parts B and D. In 2029 and each year following, HHS will continue with another 20 prescription drugs from Parts B and D.

In 2025, those covered by Medicare will not have to pay more than \$2,000 per year for out-of-pocket prescriptions.

The law also adds penalties for drug makers that raise medicine costs more than the inflation rate. Any drug company that increases their prices more than inflationary costs must pay the amount that exceeds inflation back to Medicare.

Many of these changes are good news for seniors on budgets. Also remember that open enrollment for Medicare plans will be soon. Check out your plans and see that they still meet your needs.

ROSE Recipe: Hungarian Mushroom Soup

The first time I tried this recipe I knew it was a keeper. It is a hearty, rich soup that is best served with crusty bread. I have also found it is important to follow the directions and ingredients directly. I hope you enjoy!

4 tbsp butter

2 cups onions, chopped

1 lb mushrooms, sliced

2 cups chicken or vegetable stock

1/2 cup dry white wine

2 tsp dried dill

2 tsp fresh thyme, minced

2 tsp paprika

2 tbsp soy sauce

1 cup whole milk

3 tbsp flour

1/4 cup sour cream

2 tbsp lemon juice

2 tbsp fresh Italian parsley

In a heavy pot or Dutch oven, cook onions and mushrooms in butter over medium heat until onions are soft and translucent.

Add stock, wine, thyme, dill, paprika and soy sauce, Bring to a simmer and cook until the liquid reduces by half.

In a small bowl, whisk the flour into the milk until smooth. Add to soup and cook until soup begins to thicken. Turn heat down to low and slowly stir in sour cream and lemon juice.

Serve hot and garnish with fresh parsley.

OSEA's Endorsement for Governor

know that election season can be unpleasant. But we can't fight for better wages, benefits and quality of life for OSEA and ROSE members at the bargaining table alone. I have learned from our members that we can either be at the table or on the menu. We have to use our voices -- as union members, workers and retirees, and voters -- to support each other as a union which will lift up pro-worker, pro-education candidates and policies that will help our members and families. That is why OSEA makes endorsements, and why I want to be transparent about our endorsements this year, especially in the governor's race. We followed the same process in considering the three candidates:

Christine Drazan declined to participate in OSEA's endorsement process. Candidates who refuse to talk to our members can't be endorsed, especially when they need to explain a consistent record of voting against equal unemployment insurance (UI) access.

Betsy Johnson is ineligible for OSEA support this cycle because of her vote for Senate Bill (SB) 1049 in 2019, which cut retirement benefits for thousands of OSEA members. Johnson also voted against our bill that would have lessened the impacts of SB 1049.

Tina Kotek participated in OSEA's endorsement process and generally has a good track record of supporting OSEA's priorities. Kotek was a chief architect of the Student Success Act. She listened to us about expanding access to school meals and supporting students' mental and behavioral health. She was ineligible for OSEA support when she ran in 2020 due to SB 1049, but she has supported all of our UI bills, including one which would have given educators equal access to UI benefits during the pandemic.

Given these facts, supporting Kotek for governor this year is a straightforward choice to protect workers like OSEA members in the 2023 session and beyond.

OSEA and ROSE will always respect you and your voting choices. I hope you will join me in returning your ballot as soon as you can. And please, if you are considering what vote to cast in the governor's race, look at who has shown themselves to be pro-worker.
