Joyce retired from the Navy after four years because there were no guarantees that she and Tim would remain stationed together. Tim continued to serve for 21 years with his loving wife by his side. They were stationed in the United States, Japan, Iceland, and Scotland, welcoming the opportunity to experience multiple countries and cultures abroad.

Joyce's father passed away while they were serving in Scotland, so Joyce and their son Dan returned to Roseburg to care for her mother. When Tim retired, he joined his family in Roseburg and started his second career as the network technician for the Roseburg School District.

Meanwhile, Joyce worked for a medical insurance company and then briefly for a lawyer, finally becoming a stay-at-home mom and designated caregiver for her mother.

So why have I introduced you to Joyce Stoelb? Because she is a special lady and the very picture of a giving person.

An avid crafter, Joyce learned to knit from her mother along with six of her friends in 4-H. As a youngster, she won a first-place ribbon at the Douglas County Fair for a knitted baby sweater. When I asked her how many

If knitting was not enough, her grandmother taught her embroidery. Doyou all remember the cross-stich kits you could buy? I do! Well, it turns out that Joyce used to stitch new patterns for cross stitch companies for promotional materials. She was so talented that companies would photograph her craftwork for the printed pictures in the catalog. (Yes, she received compensation for her work.)

When Tim became involved in OSEA, Joyce, as usual, was by his side. Through OSEA, Tim learned of the Labor's Community Service Agency (LCSA)'s Presents from Partners program that provides gift packages to union families across the state who need help with their holidays.

Tim supported the program over the years but even more importantly, so did Joyce. Joyce began knitting and donating her beautiful afghans for the holidays and has continued to do so for at least the last 10 years. Most of her donations have gone to LCSA, nursing homes, hospital birth and neonatal units. More have gone to neighbors and friends. Lastly, I just had to know if she had a favorite afghan pattern. She said, "Why yes, and I just completed it." She continued, "I knit a lot of afghans for others but never for me. This afghan was for me." I would say it is about time!

Joyce, thank you for being so giving of your resources, your time, and your afghans. You are one special human being!

Do you know who your representatives in the Legislature are? Have you ever had the occasion to need their help or the opportunity to visit with them? Were you happy with the outcome of previous legislative sessions? Do you like the new laws that were passed? If you answer NO to any of these questions, you might want to consider joining forces with your fellow ROSE and OSEA members this coming session and get involved. LED this year will be held on March 2nd and 3rd at the Salem Convention Center. This forum is the perfect opportunity to educate state legislators on not only OSEA issues but ROSE (and senior citizen) issues as well.

Advocacy work is an integral part of legislative sessions. It is your opportunity to have a say in the development and passage of bills. As a former school employee, LED gives you the chance to share your experiences with both state legislators and OSEA members in a small group setting. Many ROSE members have gone before you side-byside with active OSEA members to legislator offices and made the case for protecting our rights and livelihood.

Can this be a daunting task? Absolutely! Can it be intimidating? Sure! Can it be rewarding? You bet! There is nothing more rewarding (and frankly exciting) than to experience that "ah ha" moment on those legislator's faces during these visits.

Our state legislators look forward to LED and value our input. These visits give them the opportunity to ask specific questions and get a better understanding as to why a bill is being proposed in the first place. Meeting with legislators gives YOU the chance to discuss, from your perspective, how a proposed bill may potentially impact you, your fellow ROSE retirees and education in general.

Attendees will have a chance to hear from our state's elected leaders over the course of these two days. They will share their insights on the importance of LED and the legislative process. Here is a glimpse of what to expect during LED:

LED kicks off on Sunday with a one-day preparation session. Participants will be briefed on OSEA's legislative priorities and get tips and talking points for speaking with lawmakers. We

transfers ownership of assets directly to your heir without having to go through probate. We've included a template for a Last Will and Testament, as well as an explanation of the difference between a will and a trust. There need to have ROSE members in attendance to help ensure that retiree concerns are brought up during these discussions. Later that day, attendees will receive visit assignments with specific legislators. Prior to those visits, small groups will be gathered to discuss a strategy for how to address legislative priorities with their assigned politicians.

On Monday, OSEA members will meet with their elected representatives and attend committee hearings. All meetings with legislators are scheduled in advance with the allotted time usually sufficient to allow for discussion. Afterwards, participants will be asked to provide feedback on the meeting to the Government Relations team to help with follow-up.

All attendees (active OSEA members and ROSE retirees) are afforded meals, lodging and mileage for this event. It should be noted here that lodging space will more than likely be limited so registering as soon as possible for the event is important.
